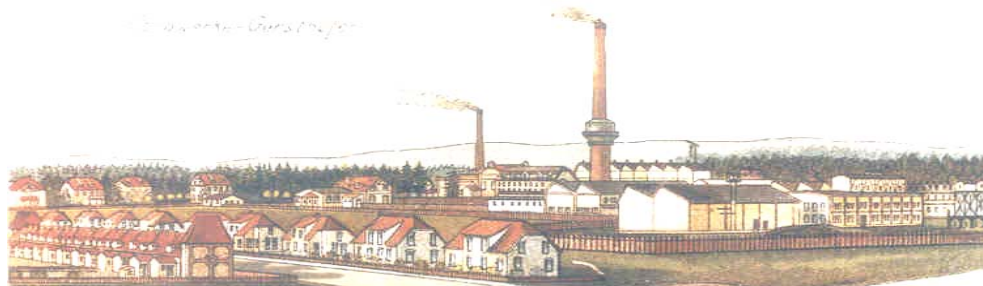
Data & Facts

- Foundation in 1899 as production site of Farbwerke Hoechst AG (first production started in 1902)
- Today a modern industrial park with a total of twelve companies
- Some 1.400 employees (around 130 trainees)
- 35 hectares in use
- Site operator: IGS

1997	Production site taken over by Clariant GmbH
2002	Foundation of Gersthofen Industrial Park, site operator: IGS
2006	IGS taken over by MVV Energiedienstleistungen GmbH

Infrastructure

- Transport Situation: site railway with main-line connection; direct connection to A8 Munich-Stuttgart autobahn and B2 federal highway
- Company fire department: 24 hrs/day; emergency organization
- Site security: watchmen 24 hrs/day; security monitored area
- Social amenities: canteen, wash and bath house, medical section, training courses
- Workshops: metal, electrical, and plastics workshops
- Stores: central dispatching section, raw-materials depots, technical equipment depot
- Communications and data network
- Supply with steam, electricity, natural gas, cooling water via pipeline network
- Environmental protection: biological sewage-treatment plant, retention tanks for contaminated water

Site operator



- Wholly-owned subsidiary of MVV Energiedienstleistungen GmbH
- IGS holds property of 35 hectares industrial site (completely developed and currently used)
- Core business: IGS offers a single source for all utilities and other basic services.
- IGS is responsible for the settlement of additional companies.
- Employees: 320 (among 130 trainees)
- Management board: Holger Amberg, Heinz Mergel, Dr. Hermann Teufel
